IN A CROSS-BORDER ENVIRONMENT



Identify & map the open science policies & resource provisioning principles applied in the Nordic and Baltic countries.



Investigate models, roles and responsibilities for the coordinated provisioning and delivery of EOSC services and resources at national level Identify current and potential **legal hurdles** associated with the sharing of data and resources across national borders. Suggest solutions.

Discuss and coordinate policy activities, and advise on directions the national initiatives should take to align with relevant EOSC policies.

# Recommendations on Legal Issues



- D2.7 Open Science in the Nordics: Recommendations on Legal Issues
  - Follow-up to D2.3: Open Science in the Nordics: Legal Insights
  - Focus on institution challenges in providing legal advice on EOSC, cross-border collaboration and cross-border data sharing

#### Recommendations

- Provide guidance code of conduct, how-to-do guidelines on the entire chain of sharing data
- Facilitate harmonisation of legal frameworks (for data sharing)
- Make EOSC relevant to institutions by facilitating cross-border data sharing
- Raise awareness of the complexities of mandates and key institutions in member states
- Offer code-of-conduct and templates for institution data sharing agreements.

## Cross-border Business Models



- D2.6 Cross-border collaboration in the context of EOSC
  - Follow-up on D2.2 Cross-Border Collaboration Models and D2.4 The EOSC Delivery Chain
  - Focus on business models for cross-border services and cross-border resource provision
  - Focus on recommendations
- Identification of business models from EOSC-Nordic demonstrators
  - Mapping of demonstrators and services
  - Interview with demonstrators, identification of cross-border resources
  - Analysis of cross-border cost recovery, business models for services and resources

## Business Models - Discussion



- No substantial business models identified in demonstrators
  - Demonstrators do not have resources to share, or have business case for
  - The landscape is fragmented
  - Researchers participate in projects to gain resources
  - Researchers may have access to national or institutional resources, but no mandate to share
  - Some researchers are "jumping from stone to stone" to get resources
- Further Investigation
  - Considering ESFRI, Cluster projects
  - Cross-border resource sharing exist in (larger) Research Infrastructures
  - Business models for cross-border services may be identified
  - Identification of types of cross-border resource and service use
